Personal data processed by How to Buy A House BV (HTBAH)

HTBAH processes your personal data because you make use of the services of HTBAH and/or because you choose to provide these data to us. Please find below a list of the personal data we process:

- All other personal data that you have provided us with or that we can obtain in connection with the purposes and on the basis of the principles that are stated below

Special categories of personal data and/or sensitive personal data processed by How to Buy A House BV (HTBAH)

HTBAH does not processes special categories and/or sensitive personal data of you insofar as provided by you, unless you are one of our business partners. If so we also processes

- Bank account details
- VAT number
- Company contact

We collect this personal data because you have provided it to us. For example: you provide data when entering into an agreement with us, by entering your details on our website or by giving us your business card. We may also obtain your personal data from other sources, such as a business relationship, the Trade Register (*Handelsregister*) or by using public sources.

The purpose and legitimate basis of the processing of personal data by How to Buy A House BV (HTBAH)

HTBAH processes personal data for the following purposes:

HTBAH processes your personal data on the basis of one or more of the following legal principles:

- Your permission.

Automated decision-making

HTBAH does not take decisions based on automated processing on matters that may have (considerable) impact on people. These are decisions taken by computer programs or systems without any human interference (for example automated refusal of an online credit application).

Retention period

HTBAH stores your personal data no longer than strictly necessary to achieve the goals for which your data is collected or to comply with applicable laws and regulations. HTBAH applies the following retention periods for the following (categories of) personal data:

Accessing, rectifying or deleting of personal data

You have the right to access your personal data, to rectify these and to delete these. Please black out your photo, the machine readable zone (the strip with number at the bottom of the passport), your passport number as well as your Dutch citizen services number (or social security number). This is to protect your privacy. HTBAH will respond as quickly as possible to your request, in any event within four weeks. HTBAH points out that you have the possibility to file a complaint with the national regulator, the *Autoriteit Persoonsgegevens*.
